Within the continuum of reproductive health care, antenatal care provides a platform for important health-care functions, including health promotion, screening and diagnosis, and disease prevention. It has been established that, by implementing timely and appropriate evidence-based practices, antenatal care can save lives. Endorsed by the United Nations Secretary-General, this is a comprehensive WHO guideline on routine antenatal care for pregnant women and adolescent girls. It aims to complement existing WHO guidelines on the management of specific pregnancy-related complications. The guidance captures the complex nature of the antenatal care issues surrounding healthcare practices and delivery, and prioritizes person-centered health and well-being --- not only the prevention of death and morbidity --- in accordance with a human rights-based approach.

Drawing upon health and population surveys, maps and analyses collected between 1963 and 2007, this fascinating interdisciplinary study explores the origins, history and development of the Ethiopian village of Kossoye. Founded in 1945, it has since been home to five generations. The fifth generation, born after the fall of Mengistu in 1991, now lives in a growing town with businesses, electricity, a health post, access to public transport and a school with 1300 students. However, they also face challenges unlike any of those faced by their ancestors.

## **The Quest for Press Freedom**

Being a home to more than 80 ethnic groups, Ethiopia has to balance normative diversity with efforts to

implement state law across its territory. This volume explores the co-existence of state, customary, and religious legal forums from the perspective of legal practitioners and local justice seekers. It shows how the various stakeholders' use of negotiation, and their strategic application of law can lead to unwanted confusion, but also to sustainable conflict resolution, innovative new procedures and hybrid norms. The book thus generates important knowledge on the conditions necessary for stimulating a cooperative co-existence of different legal systems.

This book is a social—ecological system description and feedback analysis of the Lake Tana Basin, the headwater catchment of the Upper Blue Nile River. This basin is an important local, national, and international resource, and concern about its sustainable development is growing at many levels. Lake Tana Basin outflows of water, sediments, nutrients, and contaminants affect water that flows downstream in the Blue Nile across international boundaries into the Nile River; the lake and surrounding land have recently been proposed as a UNESCO Biosphere Reserve; the basin has been designated as a key national economic growth corridor in the Ethiopian Growth and Transformation Plan. A Political History of the Tigray People's Liberation Front (1975-1991): Revolt, Ideology, and Mobilisation in Ethiopia, is a comprehensive and critical study that seamlessly integrates the theoretical issues of ethnic self-determination with real life events, processes and empirical observations of the complex history of the TPLF. Its author, Aregawi Berhe, received his doctorate in Social Studies from the Vrije University in Amsterdam. He is also one of the founders and a former commander of the Tigray People's Liberation Front (TPLF), the revolutionary movement that overthrew and replaced the Dergue-the military dictatorship that ruled Ethiopia. In this book, Aregawi unpacks the history of the TPLF and discusses its origins in the Ethiopian student movement, its organization in Tigray and the mobilization of its inhabitants, the creation of a peasant army, the factional struggles within the TPLF, its relations with other liberation movements, and, ultimately, its success in capturing state power.

## **Participatory Politics and Citizen Journalism in a Networked Africa**

This book provides a comprehensive description of groundwater resources in Ethiopia and its various dimensions (groundwater as resource, environmental functions, and socioeconomics). The prevailing knowledge of groundwater resources in Ethiopia (or elsewhere in Sub Saharan Africa) was based on geological and stratigraphic framework known nearly four decades ago (mainly 1960's and 70's). Thanks to the substantial geoscientific research since the 70's a new set of relevant geological/stratigraphic data has been created that helps to re-define our understanding of groundwater resources in Africa as a whole and in Ethiopia in particular: a) For the first

time the basement aquifer of Ethiopia has been described hydrogeologically based on genesis of regoliths (deep weathering and striping history); clear regional difference in groundwater potential is shown for the first time; comparative accounty has been given regarding groundwater occurrence in the generally low grade basement rocks of Ethiopia (Arabian Nubian shield) and high grade basement rocks of the rest of Africa. b) For the first time groundwater occurrence in multilayred sedimentary rocks account for spatial variation in degree of karstification; deformation history, and stratigraphy. c) The vast volcanic aquifers of Ethiopia which have previously classified based on their ages are now reclassified based on age, morphology (eg. groundwater in plateau volcanics, groundwater in shield volcanics) and aquifer structure. d) The loose alluvio lacustrine sediments which were known as least extensive in previous works based on areal cover are in fact shown to host the most voluminous groundwater resources in Ethiopia. These aquifers have now been described based on their geomorphology, extent, and genesis. The aim of this book is to use these newly created knowledge to redefine the understanding of groundwater resources in Ethiopia.

The adoption of ethnic federalism in Ethiopia was closely related with the problem of creating a state structure that could be used as instrument of managing the complex ethno-linguistic diversity of the country. Ethiopia is a multinational country with about 85 ethno-linguistic groups and since the 1960s, it suffered from ethno-regional conflicts. The book considers multiple governance and state factors that could explain the difficulties Ethiopian federalism faces to realise its objectives. ## **The Evangelical Movement in Ethiopia**

Subjects of Empires/Citizens of States draws on rich ethnographic and historical research to examine the interaction of the Yemeni diaspora with states and empires in Djibouti and Ethiopia from the early twentieth century, when European powers began to colonize the region. In doing so, it aims to counter a dominant perspective in Indian Ocean studies that regards migrants across the region as by-products of personal networks and local oceanic systems, which according to most scholarship led to cosmopolitan spaces and hybrid cultures. Elegantly combining theoretical readings with extensive empirical findings, this study documents a largely forgotten period in the history of Yemeni migration as well as contributing to the wider debates on class, citizenship, and ethnicity in relation to diaspora groups. It will appeal to specialists in Middle East studies and to those who study the Indian Ocean and Horn of Africa regions, as well as to migration and diaspora studies scholars, nongovernmental organizations, and policy makers concerned with the Red Sea and Gulf of Aden region.

## **Watershed Models**

Matakkal is a large region in Northwest Ethiopia along the Sudanese border. In former times it comprised nearly half of Goggam, although not counting more than 250.000 Inhabitants, who belonged to different ethnical groups. Members from all four Ethiopian language families (Semitic, Kushitic, Omotic, and Nilo-Saharan) inhabit the area. Matakkal represents thus from ethno-linguistic view a pattern of Ethiopia. The special ethnical variety of this region goes back to demographic and political changes in the Horn of Africa in the 16th and 17th centuries. Since the 16th century large subpopulations came into the region and led to an ethnical enriching. While Oromo, Sinasa and Agaw assimilated in most areas of Goggam to the dominant Amharic speaking population, in Matakkal the same subpopulations retained their ethnical identity to a large extent. The investigation is based on interviews with informants and field research, as well as on documents and archives. The study is an interdisciplinary work, which combines history, anthropology and peace research. It deals with cultures and history of the peoples in the border area between Ethiopia and the Sudan from the last decade of the 19th century up to the end of the Ethiopian Revolution in 1991.

## **Federalism and Ethnic Conflict in Ethiopia**

This thesis provides a new approach to the Ethiopian Land Law debate. The basic argument made in this thesis is that even if the Ethiopian Constitution provides and guarantees common ownership of land (together with the state) to the people, this right has not been fully realized whether in terms of land accessibility, enjoyability, and payment of fair

compensation in the event of expropriation. Expropriation is an inherent power of the state to acquire land for public purpose activities. It is an important development tool in a country such as Ethiopia where expropriation remains the only method to acquire land. Furthermore, the two preconditions of payment of fair compensation and existence of public purpose justifications are not strictly followed in Ethiopia. The state remains the sole beneficiary of the process by capturing the full profit of land value, while paying inadequate compensation to those who cede their land by expropriation. Secondly, the broader public purpose power of the state in expropriating the land for unlimited activities puts the property owners under imminent risk of expropriation.

## **Inter-ethnic Relations on a Frontier**

This collection of essays is about the lives, ideas and modes of interaction of children in Ethiopia, against the background that in-depth knowledge of perceptions of cultural values and practices regarding children would contribute to improved work with them and to the promotion of their rights as children. The study is supported by Save the Children Sweden and Norway, and the essays are a collaboration between those bodies and the Department of Social Anthropology at Addis Ababa University. Production systems as they relate to crops, livestock, fisheries and wetlands are analyzed for the whole Blue and White Nile basin including their constraints. Policy, institutional and technological interventions that increase productivity of agriculture and use of water are also assessed. Water demand modeling, scenario analysis, and tradeoffs that inform future plans and opportunities are included to provide a unique, comprehensive coverage of the subject.

## **Mediated Politics**

The supply and management of fresh water for the world's billions of inhabitants is likely to be one of the most daunting challenges of the coming century. For countries that share river basins with others, questions of how best to use and protect precious

water resources always become entangled in complex political, legal, environmental, and economic considerations. This book focuses on the issues that face all international river basins by examining in detail the Nile Basin and the ten countries that lay claim to its waters. John Waterbury applies collective action theory and international relations theory to the challenges of the ten Nile nations. Confronting issues ranging from food security and famine prevention to political stability, these countries have yet to arrive at a comprehensive understanding of how to manage the Nile's resources.
