New Rules for the New Economy

In the summer of 1914 Germany's Pacific colonies were a quiet backwater of its empire. But the shots of Sarajevo shattered the Pacific as well as Europe. Within weeks of the outbreak of World War I Western Samoa - German territory to be taken in the war - New Guinea, and the Micronesian lands, were occupied by Australian, New Zealand, and Japanese forces. Current historiography claims that World War I made little difference to the indigenous populations of the Pacific and that this change in colonial masters had little effect on those they ruled. The Neglected War challenges this interpretation. It also sheds light on the classes of pathogens (bacteria, fungus and viruses); effector molecules, such as PAMPs; receptor molecules like PRRs and NBS-LRR proteins; signaling components like

MAPKs; regulatory molecules, such as phytohormones and miRNA; transcription factors, such as WRKY; defense-related proteins such as PR-proteins; and defensive metabolites like secondary metabolites. In addition, it examines the role of post-genomics, high-throughput technology (transcriptomics and proteomics) in studying pathogen outbreaks causing crop losses in a number of plants. Providing a comprehensive picture of plant-pathogen interaction, the updated information included in this book is valuable for all those involved in crop improvement.
