The problem of action is of crucial importance in both sociology and philosophy, and this book—already widely debated in Germany—will add fresh impetus to the lively discussions current in the English-speaking world.

Urban governance and sustainability are rapidly becoming key issues around the world. Currently three billion people - half the population of the planet - live in cities, and by 2050 a full two-thirds of the world's population will be housed in ever larger and increasingly densely populated urban areas. The economic, social and environmental challenges posed by urbanization on such a large scale and at such a rapid pace are staggering for local, regional and national governments working towards sustainability. Solutions to the myriad problems plaguing the quest for sustainability at the city-level are equally as diverse and complex, but are rooted in the assumptions of the 'sustainability agenda', developed at the Rio Earth Summit and embodied in Local Agenda/Action 21. These assumptions state that good governance is a necessary precondition for the achievement of sustainable development, particularly at the local level, and that the mobilization of local communities is an essential part of this process. Yet until now, these assumptions, which have guided the policies and programmes of over 6000 local authorities around the world, have never been seriously tested. Drawing on three years of

field research in 40 European towns and cities, *Governing for Sustainable Cities* is the first book to examine empirically the processes of urban governance in sustainable development. Looking at a host of core issues including institutional and social capacity, institutional design, social equity, politics, partnerships and cooperation and creative policy-making, the authors draw compelling conclusions and offer strong guidance. This book is essential reading for policy-makers, politicians, activists and NGOs, planners, researchers and academics, whether in Europe, North America, Australasia or transitional and developing countries, concerned with advancing sustainability in our rapidly urbanizing world.

David Martin is a pioneer of a political sociology of religion that integrates a combined analysis of nationalism and political religions with the history of religion. He was one of the first critics of the so-called secularization thesis, and his historical orientation makes him one of the few outstanding scholars who have continued the work begun by Max Weber and Emile Durkheim. Certainly the price was awarded for Giuliani's great Leadership in very difficult times, but how could the committee have forgotten everything what happened before September 11th? Had Rudy Giuliani, a man who was criticized especially in Germany for his merciless behaviour toward homeless people and minority groups, now also become a hero in Germany? Before deciding what kind of character Rudy Giuliani really is, it is important to take a closer look at his background and political career. Rudolph W. Giuliani was born in a working class family in Brooklyn, New York in 1944. He is the grandson of Italian immigrants. He attended Bishop Loughlin Memorial High School (Class of '61) in Brooklyn. In high school Giuliani had been what Americans call an "extracurricular activity junkie" (Barret and Fifield 34). He was a member of the baseball and weightlifting teams. He

participated in a charity club, and even as a freshman he liked to take on responsibility and was voted homeroom president. As he grew older his interest in politics increased and he spent long nights with friends "discussing philosophy, religion and politics" (Barret and Fifield 35). In those discussions Giuliani always claimed to be a young man with very high moral standards. At the end of his senior year he was awarded "Class Politician" (Barret and Fifield 36) by his classmates. At that time nobody could have known how right their decision was. In the fall of 1961 Giuliani enrolled in Manhattan College (Class of '65) in the Bronx. The atmosphere at the all-male college was similar to his high school. There was a mandatory dress code, tardiness was treated harshly, liquor was banned from campus and women were not allowed in the dormitories. Rudy Giuliani graduated in 1965 with honors but not with magna cum laude, a fact he often emphasizes. In the fall of 1965 Giuliani entered Law school at New York University (Barret and Fifield 37-41). Rudy was already politically active at that time and a classmate remembers him as a "real Robert F. Kennedy democrat, a liberal, except on law and order" (Barret and Fifield 53). Giuliani had deeply admired Bobby Kennedy and when he was murdered "[he] thought [his] presence in national politics was irreplaceable" (Barret and Fifield 55) []

From this skillful historical and theoretical analysis, Joas creates a powerful case for the enduring legacy of Peirce, James, Dewey, and Mead for social theorists today.

### **The Little Book of Bonsai**

Zika virus (ZIKV) is a mosquito-borne member of the Flaviviridae family that historically has been associated with mild febrile illness. However, the recent outbreaks in Brazil in 2015 and its rapid spread throughout South and Central America and the Caribbean, together with its association with severe neurological disorders—including fetal microcephaly and Guillain-Barré syndrome in adults—have changed the historic perspective of ZIKV. Currently, ZIKV is considered an important public health concern that has the potential to affect millions of people worldwide. The significance of ZIKV in human health and the lack of approved vaccines and/or antiviral drugs to combat ZIKV infection have triggered a global effort to develop effective countermeasures to prevent and/or treat ZIKV infection. In this Special Issue of *Viruses*, we have assembled a collection of 32 research and review articles that cover the more recent advances on ZIKV molecular biology, replication and transmission, virus-host interactions, pathogenesis, epidemiology, vaccine development, antivirals, and viral diagnosis.

What do we talk about when we talk about "religion"? Is it an array of empirical facts about historical human civilizations? Or is religion what is in essence unpredictable--perhaps the very emergence of the new? Given the Latin roots of the word religion and its historical Christian uses, what sense, if any, does it make to talk about "religion" in other traditions? Where might we look for common elements that would enable us to do so? Has religion as an overarching concept lost all its currency, or does it ineluctably return--sometimes in unexpected ways--the moment we attempt to do without it? This book explores the difficulties and double binds that arise when we ask "What is religion?" Offering a marvelously rich and diverse array of perspectives, it begins the task of rethinking "religion" and "religious studies" in a contemporary world. Opening essays on the question "What is religion?" are followed by clusters exploring the relationships among religion, theology, and philosophy and the links between religion, politics, and law. Pedagogy is the focus of the following section. Religion is then examined in particular contexts, from classical times to the present Pentecostal revival, leading into an especially rich set of essays on religion, materiality, and mediatization. The final section grapples with the ever-changing forms that "religion" is taking, such as spirituality movements and responses to the ecological crisis. Featuring the work of leading scholars from a wide array of disciplines, traditions, and cultures, *Religion: Beyond a Concept* will help set the agenda for religious studies for years to come. It is the first of five volumes in a collection entitled *The Future of the Religious Past*, the fruit of a major international research initiative funded by the Netherlands Organization for Scientific Research.

This publication is the most comprehensive international book on arbitration in Argentina. It provides a complete description and analysis of the historical and contemporary structure of arbitration law and practice in the country, which is based on the UNCITRAL Model Law. Its chapters are authored by many of the most regarded Argentine authorities, many of whom are responsible for drafting Argentina's current arbitration regulation. Throughout its thirty-one chapters, the book covers an ample number of topics in commercial and investment arbitration, and an exhaustive analysis of arbitration in different specific fields (energy, sports, consumers, among others). Some of the topics addressed in this book include the following: regulatory framework of arbitration in Argentina; arbitration agreements; arbitral proceedings and the applicable law; issues of arbitrability; interim measures; costs and financing of arbitrations; validity, recognition and enforcement of awards; arbitration and the MERCOSUR. This publication also includes some particular studies, for example those related to the tensions between investment arbitration and human rights, as well as the relationship between the country and the ICC, and the PCA. Although mainly focused in Argentina, the discussions contained in several contributions exceed such geographical boundaries. Given that the law and practice of arbitration in Argentina has seen remarkable changes in recent decades, this book is an essential tool for arbitrators, judges, in-house counsels, global law firms, large- and medium-sized companies doing transnational business, interested academics, and international arbitration centres. Because this publication draws from the teachings and experience of leading academics and practitioners, arbitration specialists will find in it all the guidance needed to identify and assess the different theoretical and practical legal avenues available when working on arbitrations with a seat in Argentina or with an Argentine element.

At once historically and theoretically informed, these essays invite the reader to think of religion dynamically, reconsidering American religious history in terms of practices that are linked to specific social contexts. The point of departure is the concept of "lived religion." Discussing such topics as gift exchange, cremation, hymn-singing, and women's spirituality, a group of leading sociologists and historians of religion explore the many facets of how people carry out their religious beliefs on a daily basis. As David Hall notes in his introduction, a history of practices "encompasses the tensions, the ongoing struggle of definition, that are constituted within every religious tradition and that are always present in how people choose to act. Practice thus suggests that any synthesis is provisional." The volume opens with two essays by Robert Orsi and Danièle Hervieu-Léger that offer an overview of the rapidly growing study of lived religion, with Hervieu-Léger using the Catholic charismatic renewal movement in France as a window through which to explore the coexistence of regulation and spontaneity within religious practice. Anne S. Brown and David D. Hall examine family strategies and church

membership in early New England. Leigh Eric Schmidt looks at the complex meanings of gift-giving in America. Stephen Prothero writes about the cremation movement in the late nineteenth century. In an essay on the narrative structure of Mrs. Cowman's Streams in the Desert, Cheryl Forbes considers the devotional lives of everyday women. Michael McNally uses the practice of hymn-singing among the Ojibwa to reexamine the categories of native and Christian religion. In essays centering on domestic life, Rebecca Kneale Gould investigates modern homesteading as lived religion while R. Marie Griffith treats home-oriented spirituality in the Women's Aglow Fellowship. In "Golden- Rule Christianity," Nancy Ammerman talks about lived religion in the American mainstream.

Since 9/11, the Jordanian Abu Muhammad al-Maqdisi (b. West Bank, 1959) has emerged as one of the most important radical Muslim thinkers alive today. While al-Maqdisi may not be a household name in the West, his influence amongst like-minded Muslims stretches across the world from Jordan - where he lives today - to Southeast Asia. His writings and teachings on Salafi Islam have inspired terrorists from Europe to the Middle East, including Abu Mus'ab al-Zarqawi, the former leader of al-Qa'ida in Iraq, and Ayman al-Zawahiri, Osama Bin Laden's successor as the head of al-Qa'ida Central. This groundbreaking book, which is the first comprehensive assessment of al-Maqdisi, his life, ideology, and influence, is based on his extensive writings and those of other jihadis, as well as on interviews that the author conducted with (former) jihadis, including al-Maqdisi himself. It is a serious and intense work of scholarship that uses this considerable archive to explain and interpret al-Maqdisi's particular brand of Salafism. More broadly, the book offers an alternative, insider

perspective on the rise of radical Islam, with a particular focus on Salafi opposition movements in Saudi Arabia and Jordan.
