There are few practical training resources for public health practitioners, especially resources which include discussion of realistic cases which are likely to arise in the practice of public health. This work discusses these issues on a case to case basis and helps create awareness and understanding of the ethics of public health care. The main audience for the casebook is public health practitioners, including front-line workers, field epidemiology trainers and trainees, managers, planners, and decision makers who have an interest in learning about how to integrate ethical analysis into their day to day public health practice. Part II "Coastal Hydrodynamics" is organized to lead the reader from the fundamental principles of linear and other wave theories, including irregular waves and spectral analysis, to ocean wave generation and through the process of transformation as the wave approaches and reacts with the coastline. Analysis of water level variations including astronomical tides and storm surges are presented along with the hydrodynamics of coastal inlets and harbors are included in other chapters.

Cosmetic and Toiletry Formulations

This book provides an up-to-date overview of the latest evidence regarding shoulder stiffness or frozen shoulder. All aspects are covered: epidemiology, etiology, anatomy and biomechanics, clinical

There is ongoing uncertainty over its causation and continuing relative neglect due to the belief that it is a self-limited disease despite the evidence that most patients fail to achieve complete recovery, with many experiencing persistent pain and stiffness. **Shoulder Stiffness: Current Concepts and Concerns** provides an excellent summary of present knowledge regarding frozen shoulder and will be of value to all who manage the condition.
