He ended the Forum when he published the December 2013 issue after 40 consecutive years of publication. This memoir reveals the inside story of Belth's victories, partial victories, and defeats. His memoir explains why and how the Forum began and describes significant events that occurred during the four decades of operation, including those relating to life insurance, annuities, company operations, and regulation. Belth also describes his adolescent years and education prior to joining the faculty of Indiana University in 1962, and his long association with the University. -- From book jacket.
