Over the last twenty years, there has been an increasing number of factors that have placed the manufacturing strategies of companies and countries in a global context. This book reviews and addresses the global manufacturing strategy area through research in the four major economic areas of the

world: Europe, North America, Latin America and Asia. State of Readiness

different levels of analysis can be connected.
